- Sites are only formalised once both a contract & schedule have been signed and returned to Melbourne Royal® and all deposits and monies due are paid in full.
- Deposits are due within 7 days from date of receipt of contract and invoice.
- Failure to comply with payment schedule will result in forfeit of allocated stand.

Your Responsibilities as an Exhibitor

- You are responsible for organising and providing Melbourne Royal with all permits and licenses necessary for you to carry out the activities outlined in your Product specifications in the schedule of your Contract Agreement.
- Exhibitor stands must be staffed and ready to commence trade by 9:00am Thursday September 26, 2024, for the operational hours as advised by the Melbourne Royal Commercial & Exhibitor Department for the 11 days of Show.

Allocated Space and Items for Sale

- You must not sublet or allocate any portion of the allocated space to any third party.
- You must not sell or promote any product/service which has not been pre-approved by Melbourne Royal, under the definition of Product Specifications in the schedule of your Contract Agreement and must be compliant with all safety and licensing requirements, counterfeit products are not permitted on site.
- All products, displays and signage must be within the confines of the stand boundaries at all times, additional charges will apply if not adhered too.
- You cannot increase prices during the Show period.

Cancellations

- The following cancellation fees apply:
 - More than 90 days prior to the start of the Melbourne
 Royal Show 10% of Instalment 1 forfeited.
 - Between 60 90 days prior to the start of
 Melbourne Royal Show 25% of Instalment 1 forfeited.
 - Within 60 days prior to the start of Melbourne Royal Show – 100% of Instalment 1 forfeited.

Car Parking and Deliveries

- There is no complimentary exhibitor parking at the Melbourne Showgrounds, car passes can be purchased, limited numbers available.
- Vehicle delivery passes will be provided and must be displayed in your vehicle for the move in/out and Melbourne Royal Show period.
- Access for any exhibitor, supplier, stakeholder is not permitted to the Melbourne Showgrounds on Sunday 22nd or Wednesday 25th September 2024.

Competitions and Promotional Activities

- Competitions or promotional activities including signage must be pre-approved.
- Without prior approval, Melbourne Royal may request for promotions and/or signage to be withdrawn.
- No handwritten signs permitted on site without approval.

Exhibitor Passes

- Exhibitor passes are issued for the purposes of staffing your stand only. Under no circumstances may an exhibitor sell or exchange any pass provided by Melbourne Royal. Breach of this will give the Melbourne Royal the right, without notice and without incurring any liability, to terminate the exhibitor's show license.
- Please refer to the Exhibitor Manual for the number of passes allocated per stand.
- A 1-day (single) day pass provides entry for 1 staff member for 1 day of the Melbourne Royal Show.
- A 11-day (whole of show) pass provides entry for 1 staff member for all 11 days of the Melbourne Royal Show.
- Additional passes can be purchased on request at a discounted rate.

Collection of Passes

- Exhibitor passes will only be released if the Melbourne Royal holds:
- The Exhibitor Agreement & Schedule documentation signed by you
- · Full payment is received
- Completion of the OHS online induction/s
- A copy of all relevant permits, licenses, insurances, WWCC, and any other requested documentation have been provided
- Bump in is <u>not permitted</u> until the Melbourne Royal receives the above paperwork.

Your Agreement with Melbourne Royal

- Successful applicants must sign the Exhibitor Agreement & Schedule with Melbourne Royal and adhere to the Terms and Conditions contained in the Agreement, and the 2024 Melbourne Royal Show Event Manual.
- It is a requirement of your Agreement that the Terms and Conditions are read thoroughly and adhered to.
- The Exhibitor Agreement & Schedule only become binding once signed by both the Exhibitor and the Financial Controller of the Melbourne Royal Show.

Ownership and Property Rights

- In the Exhibitor Agreement you will warrant that you are the owner or operator of the product or equipment on your Permitted Use
- You will not be permitted to sell or transfer your rights under that agreement (for example by selling the right to operate or display the products or equipment to a third party
- You must not infringe the Intellectual Property Rights of any person in regard to the Permitted Use of your Exhibitor Agreement

Public Liability Insurance

- You are responsible for your own Public and Products Liability insurance and must submit a copy of your Certificate of Currency for Public Liability Insurance if your application is successful.
- Coverage must be for a minimum of \$20 million AUD.

- Your insurance must be held in the same name as your Company Name on your application and Exhibitor Agreement if you application is approved.

Storage

- Please note there is limited storage available on-site for hire outside of your site at the Melbourne Royal Show 2024 for Exhibitors.

- You are **not permitted** to store, sell or promote items outside the boundaries of your allocated stand (for example, behind or adjacent to your stand). Items may be removed and unable to be recovered, fees may apply.
